## 2. New Business

- d. A schedule for Vestry Sunday assignments will be on the Google drive, and if you are changing with someone either change the document or notify Bradley. Anne Krouse is working on a draft list of Sunday duties for Vestry members which will be reviewed next month.
- e. Bill Sena–There are some issues with getting the entire property locked up after events. Everyone should be quite careful when being the last to leave. The Vestry Member is not obligated to stay for the duration as long as the person in charge is identified.

## 3. Old Business

- b. Finance Reports: Pledges are behind 2022, but there is still an opportunity to bring more in. 22-23 pledges exceeded budget which offset the lower than budget plate revenue.
- c. The 2023 budget is not set yet. The Vestry voted to continue financial operations for January under the 22-23 Budget. Bill Sena moved, Charles Malone seconded.

## 4. Rector Report

- a. This is a time, post Covid to rethink how we do things, to ask how we re-engage people. Perhaps it is time to contact those in our directory to update data. If we have these things in place we would be able to focus on worship and formation. How do we acknowledge newcomer's presence? We will continue with coffee in the Narthex for now.
- b. The Diocese is recommending that parishes *consider* masking for a few weeks. Cases in Wake County spiked around January 1, and no county is green anymore. Wake County is more vaccinated than the national average. We will keep doing things as they are: express our concern and acknowledge that people are encouraged to wear masks and provide masks and provide hand sanitizer prominently.
